SUPPORTING DOCUMENTATION

Applications <u>WILL NOT BE PROCESSED WITHOUT CERTIFIED COPIES OF ORIGINAL DOCUMENTATION</u> by a South African registered Commissioner of Oaths authority. The commissioner of oaths should be someone who is impartial, unbiased, not related to the Healthcare Service Provider (HSP) and who has no interest in the HSP (such as any immediate family members of the HSP, any employee or employer of the HSP or any colleague of the HSP).
