

# Practice Code Number Application Form: HPCSA Professions

A Practice Code Number (PCN) is allocated based on the authority granted to the Board of Healthcare Funders (BHF) by the Council for Medical Schemes (CMS) to allocate PCNs to suppliers of relevant healthcare services. The BHF's PCN unit ("PCNS") is the entity tasked with the administration of practice code numbers. It is the responsibility of the applicant to complete the particulars required hereunder and to supply all the necessary information, as per the PCN application. The PCN unit will allocate PCNs to suppliers of relevant health services who comply with the PCNS application verification criteria.

### SUPPORTING DOCUMENTATION

Applications <u>WILL NOT BE PROCESSED WITHOUT CERTIFIED COPIES OF ORIGINAL DOCUMENTATION</u> by a South African registered Commissioner of Oaths authority. **The commissioner of oaths should be someone who is impartial, unbiased, not related to the Healthcare Service Provider (HSP)** and who has no interest in the HSP (such as any immediate family members of the HSP, any employee or employer of the HSP or any colleague of the HSP). The stamp on the certified document must be dated, include the name of the Commissioner of Oaths and the words COMMISSIONER OF OATHS and valid for 6 months from the date of certification. Please note that the BHF policy requires that in order to obtain a practice number, an applicant health care professional must be registered by a regulatory body or a licencing authority in terms of South African Law, as this is a requirement of the Medical Schemes Act (Act. No 131 of 1998).

In Accordance with Legislation and BHF Policies, a Practice Number may not be issued without the following:

- Certified copy of Identity Document
- Certified copy of the passport and proof of permanent residence permit, where the applicant is not a South African citizen.
- Certified copy of Independent Practice Registration Certificate from the Health Professions Council of South Africa
- Certified copy of Marriage Certificate or Divorce Decree (where applicable).
- Certified copy of a Dispensing Licence from the Department of Health of South Africa (if applicable)
- Proof from the Health Professions Council of South Africa that the subscription fee has been paid for the current year
- Copy of Certificate: Approval of other Remunerative Work, confirming that you have the necessary permission to practice outside of the conditions of your employment with the state (where applicable)
- Proof of payment of PCNS Application Fee (Non-Refundable)

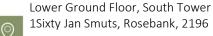
